Giles County Public Library Report – Third Quarter 2021-2022

Statistics from July 1 - March 31, 2022

Our total number of items checked out from Giles County Public Library and its branches was 50,981 as of March 31, 2022. Physical 31,432 and digital 19,549. We have also added 444 library cardholders. Our computers were used 3,608 times and Wi-Fi was used 3,907 times. We have had 24,040 in person library visits.

We have provided 95 programs in the library with: 1,126 people in attendance and 40 programs outside the library with 1,484 people in attendance. We have also offered 5 virtual programs with 105 live views.

Summer Reading:

- We are in the process of planning our Summer Reading program that will run for 6 weeks from June 6 – July 15.
- The theme this year is Oceans of Possibilities. We will have a different theme relating to oceans and programs each week with at least one special program each week including Bob Tarter's Animalogy program, Mr. Bond and the Science Guys, Barry Mitchell's Deep Sea Circus, TWRA and the creek walk, a virtual program with the Tennessee Aquarium and for adults with UT Southern on Marine biology. We will learn about ocean animals, pollution and our impact on the oceans, and recycling. Ocean myths and mysteries, the 7 seas and the countries and cultures near each. One week will be shark week and we will also have a pirate week.
- Summer Reading is for all ages.
- We will end up summer reading for everyone who participates with a blow out on Saturday, July 23 at the rec center. We are still planning this but it will coincide with first images from the James Webb Telescope. I talked about the James Webb Telescope last fall. It launched on December 25th. It is in the cool down phase right now and will be taking the first scientific images this summer. We are still working out the details for this.

We normally partner with the Kids Camp at the Recreation Center, the Boys and Girls Club and we will be partnering with Pulaski Elementary with their Summer Camp EXTREAM school program to provide some extra programs for the kids who will be attending.

Crypto Currency Program and Adult Crafting:

We have had people ask about having a program to explain crypto currency. We don't have a date yet, but we are talking to someone who has knowledge about and has some training on the subject. We hope to do it toward the end of May.

Also we are planning an adult crafting evening in May for adults to get their crafting fix in and to help with Summer Reading decorating.

HVAC and storefront windows have a lead time of 20+ weeks. Three engineers are in the county today to finalize some of the plans so that the UV-C project can be moved to the forefront. We had hoped that the first phase of the project would have begun this spring but due to the supply chain issues, it may be October or November before that work will begin.
