


**Qualification requirements for Sheriff may be found via TCA 8-8-102. Qualified citizens desiring to be candidates and whose primary residence is located within the boundaries of Giles County, except those prohibited by the Constitution and Laws of the State of Tennessee, are hereby notified of this election to be determined by a majority vote of the Giles County Commission. Qualified candidates must be POST-certified per TCA 8-8-102(b)(3)(D). Anyone desiring to be nominated for the position of Giles County Sheriff may submit a letter to the County Executive's Office to be received, no later than, Friday, Nov 8th at 12:00 p.m. to give advance notice to the Giles County Commission. Mailing address is P.O. Box 678, Pulaski, TN 38478. This will in no way prohibit anyone residing Giles County from requesting their name being placed in nomination from the gallery of the Courtroom on Tuesday, 12 Nov 2024, at 9:00 a.m. For consideration candidates must be nominated by a county commissioner.**
