**Project JLL Project**— A solvent blending facility that needs 10-30 acres. Zoned for chemical (Flammables) 60-70 jobs and high truck traffic. — Did Not Submit

**Project Condor** – They are a clean power technology company on a mission to develop, own and operate a nuclear energy production facility. z600 jobs, \$1.53 Billion investment. Need 5-20 acres, Large electrical needs. Up to 16MW. – Did Not Submit due to large electrical demand.

**Project VTC** – a Manufacturing operation for high quality specialized transformers. 700 jobs, \$250M capital investment, average wage \$70K. Need a 20-30 acre greenfield or a building 175,000 sf-expandable to 240,000 sf. – Submitted Lot 15 stating we are willing to subdivide.

**Project Dawn** – Korean Company who is a supplier to SKOn. Need existing building of 200,000 sf expandable to 400,000 sf. 50 jobs and Capital investment of \$3million plus real estate purchase. Did not submit due to existing building requirement.
