Project Updates:

Project Frost – Ready to eat food products. Need a minimum of 20 acres to be able to build a 200,000-sf building. \$115M to construct a new facility. 200 full-time jobs at completion. – Did Not Submit

Project Java – Manufacturer of coffee roasting equipment. 30-50 jobs, approximately \$5+ million investment. They require existing building minimum 50,000-sf building expandable to 75,000-100,000-sf. – Did Not Submit.

Project Basil – Manufacturer of canned beverages. Need 150-200 acres that is rail served. – Did Not Submit.

Project Mum – A frozen cookie dough company from the UK. Need a 50,000-sf existing building, 50-70 jobs, capital investment of \$5M in personal property. – Did Not Submit.

Project Verde Update – Discussions continue. Currently looking at a portion of IPS Lot 15. They are also in discussions with other local landowners outside the Industrial Park. Working to firm up the economics of the project, which look promising considering tax revenue, purchase of utilities (electric, water, natural gas) as well as potential reduction in cost of natural gas for local distribution.

Site Development Grant – Signed the official grant contract July 9 with SDG online seminar planned for July 23. Will then begin detailed engineering work to firm up scope and cost.
